Frequently asked questions about commercial disinfectants

1. How does EPA know that these products work on SARS-CoV-2?

While these products have not been tested against SARS-CoV-2, the cause of COVID-19, they are expected to be effective based on: Demonstrated efficacy against a harder-to-kill virus; Qualified for the [emerging viral pathogens claim](#); or Demonstrated efficacy against another human coronavirus similar to SARS-CoV-2.

SARS-CoV-2 is a new virus. Such pathogens are often unavailable commercially for laboratory testing.

2. Why aren't hand sanitizers listed?

EPA reviews and regulates antimicrobial pesticides, which include surface disinfectants for use on pathogens like coronavirus. List N only includes EPA-registered surface disinfectants. Hand sanitizers are regulated by Food and Drug Administration.
